<p>Violation #13. Food in good condition, safe, & unadulterated Dented can in dry storage on rack (Corrected) CODE REFERENCE: 64E-11.003(1). The food packaging shall not be compromised nor the true appearance, color, or quality of a food be intentionally altered.</p>
<p>Violation #15. Food separated & protected; Single-use gloves - Raw beef stacked over cooked beef in WIC CODE REFERENCE: 64E-11.003(2). Foods shall be stored and handled to prevent cross-contamination. Raw animal foods shall be separated from RTE food and from other raw animal food during storage, preparation, holding, and display. Single-use gloves shall be used for only one task and purpose and discarded when damage occurs or the task is interrupted.</p>
<p>Violation #43. In-use utensils: properly stored -Scoop without handles stored in rice bin in dry storage room. CODE REFERENCE: 64E-11.003(4). The establishment shall use an approved method for the storage of in-use utensils during pauses in food preparation or dispensing.</p>
<p>Violation #55. Facilities installed, maintained, & clean Mop stored wet head down in mop closet (Must be able to air dry) (Corrected) CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>
